ABSTRACT

This project mainly aims at developing a real time distributed application that reflects Supply Chain Management and to automate the process of product movement between the retailer and end user. This application automates the existing traditional help system bv the of computerized equipment's so that the product movement between the retailer and the end user is easy.

I. INTRODUCTION

"Distributed Supply Chain Management System in the Pharmaceutical Industry" is a web application. With, the help of this application users can order medicines online without having to go to storefront pharmacies. The users can get the list of nearby pharmacies by providing the location, which will list all the pharmacies within 25km. This will also display the route map in which the listed pharmacies are marked.

Users can add the pharmacies to their favorite list. Once the pharmacies are added to their favorite list, customers can order from any of the pharmacies from their favorite list.

Once the user selects the pharmacy to order medicine they can search for the particular medicine and check for the availability of the product, if available they can order the medicines by adding it to cart by specifying the quantity and uploading the doctor's prescription. Order will be processed only if the prescription is uploaded. Medicines can also be ordered based on the previously uploaded prescriptions. The ordered medicines will be deducted from the drug stock once the medicine is ordered. The system will auto generate alert once the product reaches to its minimum level. Once the order is dispatched

user can track the order. Payments can either be online i.e. EPayment or cash on delivery.

If, the user wants to return the product they can either cancel the consignment or return the product. To cancel the order, the user needs to specify the valid reason. The product returned will be restocked. In, case of product replacement new purchase order is generated. The activities associated with returns, reverse logistics are also managed.

II. LITERATURE SURVEY

In the existing system distributors, and the retailer use their own ways to process the data. There was no link between the distributor, retailer, and the customers.

Many a times people need to travel long distance to a traditional storefront pharmacy to buy medicines, checking for availability and if it's not available moving to some other pharmacy. The latitude and longitude of the location is found and accordingly the pharmacies are listed. By default, the present location of the customer is considered. This module also displays the route map in which all the listed pharmacies are marked. User can also add the pharmacy to the favorite list, to add the pharmacy to the favorite list the user needs to login into the system.


Once the pharmacies are added to their favorite list, customers can view the list and order from any of the pharmacies from their favorite list.




(Fig 2: Screenshot- Search Product)

Doctor's prescription. On the confirmation of the order, the message is sent to the user regarding the order confirmation. The ordered drug will be reduced from the stock.




(Fig 3: Screenshot- Cart)

View orders:


