above mentioned scenarios ISO has been developed.

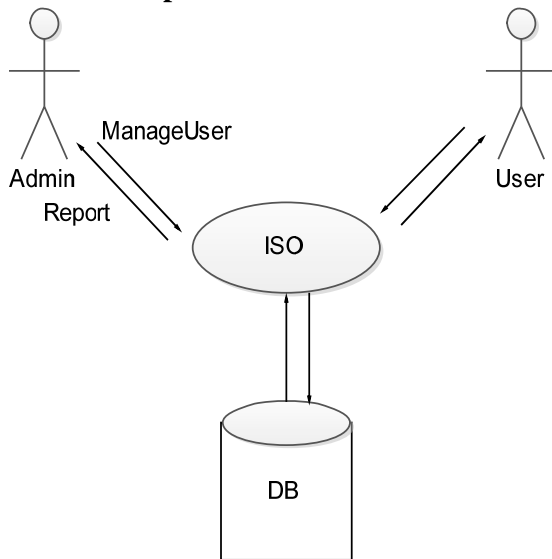
### II. Literature Survey
